- e) A position of trust in a charity or voluntary organisation in the field of health and social care;
- f) Any connection with a voluntary or other organisation contracting for NHS services:
- g) A close relative involved in any of the above.

The Register is formally updated on an annual basis and was last completed in September 2011 for the Care Trust Plus Board. As the CCG Governing Body has delegated responsibility for significant decision making in preparation for authorisation, it was felt prudent to establish good governance arrangements for this meeting.
